Ms Mary Malia Manager Independent Schools (IS)

The Evaluation and Accreditation (E&A) unit is excited to introduce Ms Mary Malia, Manager, Independent Schools (IS). Ms Mary Malia was deployed to this position with effect from January 2017.

Ms Malia was appointed at Umalusi as Assistant Manager in the evaluation and accreditation of Independent Schools' sub-unit from June 2014 to September 2015. She served under Ms Cindy Thomas who was the Manager in the sub-unit at that time. Ms Malia was then promoted to Manager in the evaluation and accreditation of private assessment bodies (AB) and Adult Education and Training (AET) sub-unit from October 2015 to December 2016.

Prior to her appointment at Umalusi, Ms Malia worked at the Gauteng Education District Office as an assessment official for the Further Education and Training (FET) phase. She worked very closely with independent schools in the management of school based assessment (SBA) to ensure that the SBA delivered at the

end of the year is fair, valid, reliable and authentic. In addition, she served in the Provincial Assessment Team. She has a Masters' degree in Education, Bachelor of Arts (Honours) in Industrial Psychology, Bachelor of Arts degree and University Diploma in Education (UDE).

What it means to be professionally qualified:

The published Government Gazette (GG) (No. 34467) Minimum Requirements for Teacher Education Qualifications (MRTEQ) of September 2011, sets out the minimum professional qualification for a South African teacher. Under the policy a teacher having completed the initial teacher education (ITE) obtains either a four-year Bachelor of Education (B Ed) degree or a one-year Post Graduate Certificate in Education (PGCE) after a three-year undergraduate degree. Both are four-year qualifications, the current official requirement for a qualified teacher in South Africa known as M+4, a matric (school-leaving) certificate plus four years of ITE.

As such, the four year Bachelor of Education degree (B Ed) at National Qualifications Framework (NQF) Level 7 or a teacher professionally-focused year Post Graduate Certificate in Education (PGCE) after an approved three-year undergraduate degree at NQF Level 7 or 8 or a Department of Higher Education or training (DHET) approved Diploma in specified fields at NQF Level 6 are approved professional qualifications.

Upon completing the ITE, teachers apply for professional certification as a teacher with the South African Council for Educators (SACE) and are issued with a registration number and placed on the national database. Teachers who have not yet fully met the requirements of a fully professional teacher would receive a conditional (C) or provisional (P) registration with an expiry date. Until such time as the teacher has met the conditions for full registration, he/she will not be deemed as professionally qualified.

Teachers with a foreign teacher qualification which has been evaluated and certified by the South African Qualifications Authority (SAQA) as having a professional teaching qualification are deemed as being professionally qualified.

Chapter 3 of the South African Council for Educators (SACE) Act (No. 31 of 2000. GG 21431) states that only teachers with SACE registration may be legally employed in both public and independent schools in South Africa and that they should be in possession of the registration certificate before being employed as a teacher. The Act also provides regulations for the registration of conditionally or provisionally qualified teachers and their subsequent appointment.

Until recently, M+3 (matric plus three years of ITE) was the official teacher requirement, so many teachers in South Africa are qualified with M+3.

Recognising the diverse challenges schools face in appointing professionally qualified and SACE registered teachers, Umalusi applies a minimum criterion of 80% professionally qualified and currently SACE registered teachers as one of the criteria to be considered towards accreditation.
